### REPORTS ON ISSUES PREVIOUSLY RAISED:

#### BUGBROOKE TO KISLINGBURY ROAD: *(Previously minuted at PC06/6/110)*

In 2006 the Parish Council had asked NCC to assess the safety of the C54 road between the two villages, following a spate of accidents. No comprehensive response had ever been received so the Clerk had chased the matter in January and again received no response. A further attempt in March had resulted in a letter from Steve Barber, Casualty Reduction Officer to say that he would be investigating the road in April and would report back afterwards.

#### AFFORDABLE HOUSING SURVEYS: *(Previously minuted at PC08/3/50)*

Laura Welch from SNC would attend the June Parish Council meeting to give an update but initial analysis revealed there were as many as 60 properties required.
